

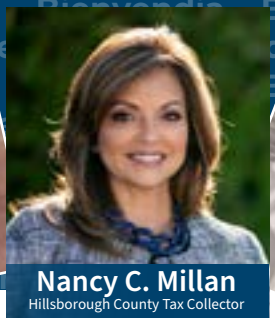

Welcome to Hillsborough County!

This guide is a brief description of the process to obtain your identification card or driver's license in the state of Florida.

The Hillsborough County Tax Collector's office is an agent of the Department of Highway Safety and Motor Vehicles. In our office we process:

- Issuance of Driver's Licenses and Identification Cards
- Motor Vehicle Titles and Registrations
- Mobile Home Titles and Registrations
- Parking Permits for People with Disabilities

Other services offered in our offices:

- Payment of Local Property Taxes
- Payment of Tangible Taxes
- Payment of Commercial Business Taxes
- Payment of Tourism Development Taxes
- Certified Copies of Florida Birth Certificates
- Concealed Gun Licenses
- Permits for Rental Vehicles
- Hunting and Fishing Licenses

The fees collected are immediately distributed to the appropriate agency or municipality to fund vital services at the state and local level.

Definition of US Citizen, Immigrant, and Non-Immigrant

Before continuing, we remind you that there are three classifications: United States Citizen, Immigrant, and Non-Immigrant. For your convenience, we will define each classification so that you know which one you are in.

Definition of United States Citizen

You are a United States citizen if you were born anywhere in the United States or its territories, including Puerto Rico, Guam, and the United States Virgin Islands. And if you were born in another country and later naturalized, you are also a US citizen.

Immigrant Definition

An immigrant is defined as a “permanent resident alien” who is admitted to the United States as a lawful permanent resident.

Immigrants are granted the privilege of permanent residence in the United States and the United States Citizenship and Immigration Services (USCIS) agency issues immigrant visas or adjusts status to permanent resident.

Definition of Non-Immigrant

People who have not yet adjusted their status to permanent resident are known as non-immigrants.

The Department of Homeland Security (DHS) defines you as foreign nationals temporarily admitted to the United States within the classes of admission that are defined in section 101 subsection (a) subsection (15) of the Immigration and Nationality Act (INA) .

Although our office makes an effort to keep the community informed, traffic laws and legal status change frequently.

United States Citizen: Requirements To Obtain Your Driver's License or Identification Card

U.S. citizens applying in person for a renewal, replacement, or application for a Driver License or Identification Card must present the following documents before a Driver License or Identification Card that meets the standards of the Real Identification Act can be issued. Please note that the name assigned on the Social Security Number must match the name that will appear on the Florida Driver's License or Identification Card. Customers who have recently changed their name should update their information at the Social Security Administration Office before applying for a Driver's License or Identification Card.

All applicants **must** meet the following requirements:

1. Provide proof of your identity and legal presence
2. Provide proof of your social security number
3. Provide two proofs of your residential address

Consumer Alert

An **International Driving Permit (IDP)**, often referred to as an international driving license, is a translation of a domestic driving license that allows the holder to drive a private motor vehicle in any country or jurisdiction that recognizes the document. To be valid, the **IDP MUST be issued by and accompanied by a valid driving license from the applicant's country of residence.** The permit is valid for up to one year from the date of issue.



Beware of IDP scams. Scammers may try to sell you a fake IDP. You may be subject to travel delays or legal issues if you use a fake IDP in the U.S.

Immigrant: Requirements To Obtain Your Driver's License or Identification Card

All applicants **must** meet the following requirements:

1. Provide proof of your identity and legal presence
2. Provide proof of your social security number
3. Provide two proofs of your residential address

Step 1: Prove Your Identity and Legal Presence

There are several categories within the classification of immigrants. In this section we will present each one so that you know what documents to bring to prove your identity and legal presence.

<p>Permanent Resident If you are a permanent resident you must present one of the following options: Green card, up-to-date passport with I-551 stamp, or up-to-date passport with I-551 notation on your VISA.</p>	<p>Asylee If you applied for asylum in the United States, you must present one of the following options: Up-to-date passport with the judge's order or up-to-date passport with receipt of your approved I-589 application. Note: If you bring the permanent resident card, the passport is not necessary.</p>
<p>Refugee If you are a refugee, you must submit one of the following options: Support with your I-94 form with the corresponding stamp or Letter from the United States Citizenship and Immigration Service (USCIS) verifying your status.</p>	<p>Note! If your case does not fall into any of these categories, please email us at this address: newresident@hillstax.org (Your documents contain confidential information about you. Please do not send photos or copies of your personal documents.)</p>

**All documents must have the ALIEN number.
We only accept original documents.**

If you have immigrated to the United States, the license and identification card systems communicate electronically with the United States Citizenship and Immigration Services (USCIS), which determines whether your credential can be issued in our offices for the period of time indicated.

If the system does not issue the credential during your visit, verification will take place at another level from the headquarters in Tallahassee and could take up to 60 days to receive.

Step 2: Submit your Social Security Number

This number is **required** for all US citizens and permanent residents, without exception.

Acceptable documents include Social Security card, Form W-2, or Form 1099 with complete number.

The name, surname and date of birth will be verified in our offices. US citizens must notify the Social Security Administration of any name change at least 24 hours before reporting to our offices.

Permanent residents and nonimmigrants must report and receive acknowledgment from USCIS of any name change. In addition, they must report the new name to the Social Security Administration at least 24 hours before appearing at our offices.

Step 3: Show Evidence of Your Residential Address

Applicants **must submit two (2)** documents in their name showing their residential address.

The address must include the property number, full street name, apartment or unit number (if applicable), city, state, and ZIP code number.

Some examples of accepted documents include, but are not limited to:

- Property registration documents or property rental contract
- Mortgage statement
- Voter registration (card)
- Vehicle registration or title in the State of Florida
- U.S. Postal service change of address receipt
- Bills for services such as cable, water or electricity, or the connection order for these services

- Statement of medical services account
- Car insurance policy
- Correspondence from a government agency

Do you only have one document under your name?

If the applicant can only present one document that shows their name and residential address, they can provide at least one document in their name and fill out the form called "Certification of Address."

Additionally, you can type "Certification of Address" into the search button on our website (hillstax.org) to find the form.

If you do not have internet access and a printer, you can visit one of our offices and one of our employees will provide you with a copy.

Do you live with family or friends?

If the applicant is unable to provide documents showing their name and residential address, they may **provide two (2) documents** in the name of the person with whom they reside, along with a document showing family relationship (birth or marriage certificate).

If the resident of the dwelling is not an immediate family member, the applicant can print the "Certification of Address" form, which must be signed by both people and notarized.

Our employees can also authenticate such a document, as long as both people present themselves at our office with acceptable identification (an up to date driver's license, identification card or passport).

Note: Once you have changed your address, you have 30 days to report the change of address.

Non-Immigrant: Requirements To Obtain Your Driver's License or Identification Card

People who have immigrated to the United States **must have an established case with USCIS and an ALIEN number** (identification number assigned to an alien by USCIS). Required documents may vary. If the applicant does not have a pending case or immigration status, they must seek assistance on their own.

If you have immigrated to the United States, the license and identification card systems communicate electronically with the United States Citizenship and Immigration Services (USCIS), which determines whether your credential can be issued in our offices for the period of time indicated.

If the system does not issue the credential during your visit, verification will take place at another level from the headquarters in Tallahassee and could take up to 60 days to receive.

Applicants in the non-immigrant category will receive their credential with **TEMPORARY** status and its validity is determined by the expiration date of the document presented, or one year.

This also means that you will need to present identification documents and USCIS documents at our offices each time you apply for a replacement or renewal, until you have become a permanent resident.

I-797 NOTICE OF ACTION receipts provided by USCIS are issued to notify you of the receipt or approval of a case. For purposes of applying for a driver's license or identification card, the date of receipt indicated in these letters may not be greater than 3 years.

Step 1: Prove Your Identity and Legal Presence

Step 2: Prove your Social Security Number

If you fall under a category where your status allows you to work in the United States, you will need to present your social security number.

Otherwise, you will have to present evidence that you are present in the United States in a status that is not related to a job or employment.

The reason for the ineligibility cannot be because you failed to present the necessary documents.

Note: If you are a non-immigrant and at some point you were issued a social security card and it never came in the mail or was lost, you need to make sure you get your social security documents and present them to our offices.

Step 3: Show Evidence of Your Residential Address

Applicants **must submit two (2) documents** in their name showing their residential address.

The address must include the property number, full street name, apartment or unit number (if applicable), city, state, and ZIP code number.

Some examples of accepted documents include, but are not limited to:

- Property registration documents or property rental contract

Steps to Obtain a Driver's License

Driving in the State of Florida is a privilege, not a right. All applicants must have adequate physical and mental capabilities to operate a motor vehicle on the public highways of the State.

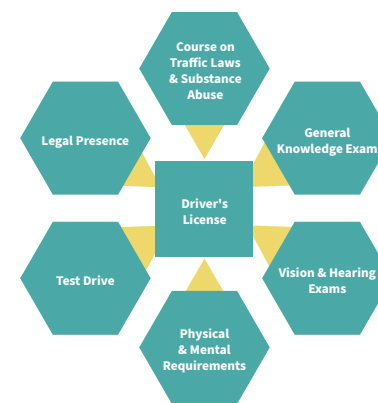
Note: Exchange and Reciprocity

The State of Florida recognizes driver's licenses from some countries, validating general knowledge and driving tests.

If you have a driver's license from Canada, France, the Republic of Korea (South Korea), or the Republic of China (Taiwan), be sure to bring it with you when you arrive at one of our offices and then our representatives will check your vision and hearing.

Note: If you have a German driver's license, only the driving test is validated and then you will have to complete the general knowledge test.

Applicants holding a license from another state, US territory will be required to surrender their license. Those presenting the Canadian license will also have to present it, unless they choose to take the general knowledge and driving tests.



When a driver's license has expired for more than 12 months, the applicant must pass the State of Florida General Knowledge test.

If you do not have one of these driver's licenses, you must meet the following requirements.

Course on Traffic Laws and Substance Abuse (Alcohol and Drugs)

If you do **NOT** have a driver's license from another country, you must pass the Traffic Law and Substance Abuse course before obtaining a driver's license. If you have a license from your country, this course will **NOT** be required. Show your license at the time of being assisted in our offices. Your license must be legible, and photocopies of your license will not be accepted.

Note: We cannot accept licenses that have been issued digitally, such as licenses from Venezuela that were delivered by email.

There are several schools that provide the Traffic Law and Substance Abuse class, either online or by attending in person. Our organization does not offer this class.

General Knowledge and Traffic Signs Test

The class E license is the license that allows you to drive vehicles with a maximum of 26,000 pounds of gross weight, with a maximum of 16 people including the driver, and recreational vehicles.

The Class E exam is based on the Florida State License Handbook, which can be found on the Florida Department of Vehicle and Highway Safety website: <https://www.flhsmv.gov/pdf/handbooks/englishdriverhandbook.pdf>

The theoretical exam is offered in most of our offices, as well as in private driving schools. You will do the theoretical exam on a computer and you will have 60 minutes to complete it. It consists of 50 questions about laws and traffic signs and a minimum of 40 correct questions is required to pass it.

Vision and Hearing Screening

Your vision (distance) and hearing will be tested. If you wear glasses, contact lenses, or hearing aids, please remember to bring them.

Glasses you wear only for reading or looking up close will **NOT** work for you on this test as we will be testing your ability to see from a distance.

If you do not pass the vision screening, you will be referred to an ophthalmologist or optometrist for a medical exam. The doctor must complete a form that must be presented in our office.

If you have passed the vision test with glasses or contact lenses, you must wear them while operating a vehicle. You can get a ticket if you don't use them.

Physical and Mental Requirements

You must indicate any physical or mental problems that may affect your ability to drive during your license application, such as epilepsy, fainting spells, dizziness, or any other medical condition that may affect your ability to drive.

Learning License (Restricted)

If you don't know how to drive, or want to practice on public roads before going for your driving test, once you have passed the knowledge test you will need to obtain a "Learner's Permit" (known as a restricted license).

Our office does not offer driving lessons; you will need to locate an instructor on your own.

People who have established domicile in the state will NOT be able to drive with the license of another country.

While you have a restricted license you must drive with a person next to you. This person must be at least 21 years old, possess a valid driver's license, and who will be in charge of monitoring you in the vehicle sitting in the front passenger seat while driving. The first three months that you will use this license you will only be able to drive during the day.

Persons over the age of 18 are not required to obtain a learner's license. If you already know how to drive, you can schedule the driving test once you have completed the Traffic Law and Substance Abuse class and the general knowledge test.

Note: Under 18 Years Old

Anyone under the age of 18 must be accompanied by a biological parent or legal guardian to obtain a learner's license. If the parents cannot accompany the minor to the office, they must submit form 71142, previously authenticated by a notary, in which they give consent for the minor to drive. This form can be obtained on the website: flhsmv.gov/pdf/forms/71142.pdf

Minors must hold the license for a minimum of one year (no points), or until they turn 18 if they got it at age 17. For the complete list of underage driving restrictions, please refer to the flhsmv.gov website or the direct link flhsmv.gov/driver-licenses-id-cards/licensing-requirements-teens-graduated-driver-license-laws-driving-curfews/

IMPORTANT: If you were not born in the USA, our systems will communicate electronically with USCIS (Immigration) to confirm your

legal status. Your learner's license may not be issued immediately, but will be mailed to you from headquarters in Tallahassee. We will give you a piece of paper that will allow you to practice while you receive your credential; however, this does not serve as identification.

Driving Test

Road Test services are available by appointment ONLY and to Hillsborough County residents ONLY.

Make sure you have the skills and experience to drive safely. If you don't feel safe behind the wheel, it's a good idea to ask a private driving school for help. The driving test can be scheduled at some of our offices or through a private driving school.

You must have completed the Traffic Law and Substance Abuse class (or present a foreign driver's license) as well as the general knowledge test prior to taking the test.

Minors must have held their learner's permit for one year, with no points on their license from penalties. The parent or legal guardian must certify that the minor has practiced behind the wheel for a minimum of 40 hours during the day and 10 hours at night.

If you are a U.S. citizen or permanent resident and do not have a star on your Florida identification card or learner's license, you must also show documents establishing your lawful presence in the country, described in the Steps to Obtain a Driver's License or ID card. If you are classified as a nonimmigrant, you must present your documents each time you come to our offices to process driver's licenses or identification cards. If you did not bring your Immigration documents, the license will not be issued.

If you have a learner's (restricted) license, you must turn it in at the time of your driving test. If you have not received it, you will be able to take the road test but the driver's license will not be issued.

Test Drive Procedure at Our Offices

The following requirements will be verified at the time of starting the test:

- Have a valid license plate.
- Have a valid vehicle registration.
- Have proof of valid Personal Injury Protection and Property Damage Liability Insurance.
- Pass a vehicle safety inspection.
- Have operable seatbelts (exception: cars manufactured prior to 1968 and trucks manufactured prior to 1972).

The representative of our office is referred to as the examiner. This person will be in the vehicle with you while you perform the test. If English is not your first language, you may bring a companion with you that will serve as your translator. If you are unable to find a translator to come with you, our staff is equipped with handheld translation devices to provide service to non-English speaking customers, available in 82 languages, including Spanish. You can request one upon arrival.

No other passengers or pets are allowed in the vehicle during the test.

Please consult the Official Florida Driver License Manual for detailed information on the maneuvers that will determine your ability to drive a vehicle.

Once you pass the driving test you will be able to obtain your driver's license. If you don't approve, you must come back another day. Retakes of this exam are not permitted on the same day.

Frequently Asked Questions

1. What if I am not licensed from my country and have not completed the Traffic Law and Substance Abuse class? What if I didn't bring my Immigration documents either?

Your license will not be processed.

2. Why did other people get the credential instantly, but it's going to arrive in the mail for me?

The system for issuing licenses and identification cards communicates electronically with various systems such as the Social Security Administration, or the United States Citizenship and Immigration Service (USCIS), among others. These systems determine if your license is issued the same day. Sometimes the systems do not confirm your legal status and the headquarters in Tallahassee will handle the issuance.

3. They told me that my license is going to arrive in the mail and that the temporary driving permit is going to expire. What I can do?

Your application is being processed from our headquarters in Tallahassee and the time this process takes is out of our control.

If the permit is close to its expiration date, please check to see if the credential has already been submitted by going to <https://services.flhsmv.gov/DLCheck/> or by calling 850-617-2000 to speak with a representative of the Department of Vehicles.

You can also bring your Immigration documents to our offices to consult with the Department. If the Department has not processed your credential, we may be able to issue another temporary driving permit.

4. How often do I need to renew my license? How far in advance can I renew it?

In general, citizens and permanent residents who are 79 years old or younger obtain the license for 8 years. The other people obtain the license for the time determined by the USCIS Citizenship and Immigration Service.

You can renew your license or identification card 18 months in advance.

5. Can I change my address online? How long do I have to change my address?

Citizens and permanent residents who have a star in the upper right corner of their license or identification card can open an account on the Department of Vehicles portal and request a replacement of their credential. Visit myDMVportal.flhsmv.gov. If you were unable to process the transaction through this portal, you must report to our offices and meet the residential address requirements.

If your card says "TEMPORARY" you must go to a Tax Collector's office with your immigration documents and meet the residential address requirements.

The law requires that the change be made within 30 days.

6. Why was my old ID taken away when I changed addresses?

The new Federal law states that you can only have one valid credential in your possession.

7. I want to ride a motorcycle. What should I do?

These classes are given by private companies that take care of all the exams. For a list of providers, please refer to the website www.flhsmv.gov or the direct link flhsmv.gov/driver-licenses-id-cards/motorcycle-rider-education-endorsements/safety-course-locations

Once you have completed this class, come to our offices to add the endorsement to your current license. Be sure to bring your USCIS documents if you are NOT a citizen or permanent resident, with a star in the upper right corner of your card.

8. Are they open on Saturdays?

No.

9. Can I pay traffic tickets at this office?

No. The ticket the officer gave you usually has instructions next to or on the back.

If you received a citation in Hillsborough County, you can visit the court's website www.hillsclerk.com for instructions on how to pay. You can also check with AMSCOT offices to see if you are eligible to pay through their agencies.
